At St. Joseph's Catholic Primary School, our priority is the safety, happiness and well-being of our children. We take our role as safeguarding and child protection officers very seriously and we will always deal with safeguarding and child protection cases quickly, following full National and Lancashire County Council procedure and protocol.

If you have any concerns about a child's safety or welfare, please do not hesitate in contacting Miss Rachael Griffiths – our Designated Safeguarding Lead (DSL) and Headteacher, Mrs Louise Beaumont (Deputy Headteacher), Mrs Nicole Dodd (SENDCo), Mrs Ceri Hamer (Behaviour and Pastoral Lead) or Miss Emma Roberts (Key Stage 1 Phase Leader). We work with many agencies, as appropriate and necessary and we are an operation Encompass school.

We are committed to safeguarding and promoting the welfare of children and we expect all staff and volunteers to share this commitment. Handy leaflets are kept in our school entrance area to advise new staff or volunteers on Positive Behaviour strategies and Child Protection advice.

Our safeguarding and child protection governor is Fr. John-Paul Evans. If you have any concerns about Miss Griffiths (Headteacher), please contact Fr. John-Paul Evans. Any whistleblowing or staff allegations must be referred immediately to Miss Griffiths and full procedure will be followed. All policies are kept in the school office, in the staff rooms of each building and the safeguarding boards contain information. Referral forms and LADO advice, alongside 7-minute meetings and information on Prevent, Keeping Children Safe in Education 2025, Safer Working Guidance 2025 and more are accessible on the teacher shared drive.

We have a number of policies and procedures in place that contribute to our safeguarding commitment, including this Child Protection Policy.

Sometimes we may need to share information and work in partnership with other agencies, when there are concerns about a child's welfare. We will ensure that our concerns about our pupils are discussed with parents/carers first, unless we have reason to believe that such a move would be contrary to the child's welfare. Our aim is to work in partnership with families, whenever possible to prevent concerns escalating to child protection issues. Early intervention is paramount. Please always come and talk to us if you have any concerns.

We actively support the Government's Prevent Agenda to counter radicalism and extremism.

We will always work to:

- Protect children and young people at our school from maltreatment;

- Prevent impairment of our children's and young people's health or development.
- Ensure that children and young people at our school grow up in circumstances consistent with the provision of safe and effective care.
- Undertake that role to enable children at our school to have the best outcomes.

### Educational Visits and visitors

Mrs Rebecca Hamilton is our Educational Visits Coordinator. All school trips are thoroughly risk assessed and uploaded to [www.kymallenhsc.co.uk](http://www.kymallenhsc.co.uk) for legal oversight. Miss Griffiths (Head teacher), Mrs Hamilton (EVC), and the Mater Christi Trust To receive plans 4 weeks in advance for approval for residential trips.

The purpose of this safeguarding policy is to ensure every child who is a registered pupil at our school is safe and protected from harm. This means we will always work to:

- Protect children and young people at our school from maltreatment
- Prevent impairment of our children's and young people's mental and physical health or development
- Ensure that children and young people at our school grow up in circumstances consistent with the provision of safe and effective care
- Undertake that role so as to enable children at our school to have the best outcomes.

This policy will give clear direction to staff, volunteers, visitors and parents about expectations and our legal responsibility to safeguard and promote the welfare of all children at our school.

Our school fully recognises the contribution it can make to protect children from harm and to support and promote the welfare of all children who are registered pupils at our school.

No single professional can have a full picture of a child's needs and circumstances. If children and families are to receive the right help at the right time, everyone who comes into contact with them has a role to play in identifying concerns, sharing information and taking prompt action.

This policy applies to all pupils, staff, parents, governors, volunteers and visitors.

- Report lower-level concerns to the DSL.
- Monitor all pupils, particularly those that are deemed vulnerable.
- Report any concerns regarding adults conduct to the DSL.
- All staff, if they have concerns, should be act immediately and should always speak to the DSL or Deputy, recognising that early information sharing is vital in keeping children safe. In exceptional circumstances staff will consider speaking to a member of SLT or Children's Social Care to discuss safeguarding concerns if the DSL is not immediately available as all staff are aware that ANYBODY can make a referral.
- **All** staff should be aware of the process for making referrals to children's social care and for statutory assessments under the Children Act 1989, especially section 17 (children in need) and section 47 (a child suffering, or likely to suffer, significant harm) that may follow a referral, along with the role they might be expected to play in such assessments.

**The Governing Body will:**

- Ensure that the policies, procedures, and training in St. Joseph's are effective and comply with the law at all times.
- Ensure that safeguarding policies and procedures are followed by all staff
- Put in place safeguarding responses in cases where children go missing from education
- Appoint a DSL and back-ups and ensure that they are provided with appropriate support, funding, training, resources and time to carry out their role
- Ensure the school contributes to inter-agency working in line with statutory guidance [Working together to safeguard children - GOV.UK \(www.gov.uk\)](http://www.gov.uk)
- Ensure that safeguarding procedures take into account local guidance including the Lancashire thresholds on the continuum of need. [Assessment - Lancashire Safeguarding Children Board](#)
- Ensure that staff members undergo safeguarding training at induction.
- Ensure that DSLs and all staff, volunteers and Governors are trained and updated regarding safeguarding regularly in compliance with **Keeping Children Safe in Education 2025**.

- Ensure that children are safe online by ensuring that appropriate filters and monitoring systems are in place.
- Ensure that safeguarding is embedded within the curriculum.
- Prevent people who pose a risk of harm from working with children.
- Ensure there are procedures in place to manage allegations against teachers, head teachers, principals, volunteers and other staff including supply staff
- Ensure staff in school are aware of, and policies reflect, an understanding of specific issues such as child on child abuse and safeguarding children with disabilities and special educational needs.
- Ensure that all practice and procedures operate with the **best** interests of the child at their heart
- Appoint a designated teacher to promote the education of CLA.
- Ensure that all staff are aware of safeguarding issues and vulnerabilities associated with CLA.

**The DSL will:**

**Be fully familiar with the role of the DSL as detailed in Keeping Children Safe in Education 2025, Annex B and adhere to this role. This includes but is not conclusive to: -**

- take **lead responsibility** for safeguarding and child protection.
- act as a point of contact with the 3 safeguarding partners
- manage referrals to Children's Social Care, Police and other agencies including Channel
- work together with other agencies in order to improve outcomes for children
- attend DSL training every 2 years.
- undertake Prevent awareness training every year
- update their skills and knowledge on a regular basis, but at least annually.
- raise awareness of safeguarding throughout school and act as a point of support for all staff
- ensure that this policy is reviewed annually and is available publicly.
- maintain, update, and amend the school's safeguarding portfolio regularly.
- ensure that parents are aware of school's responsibilities regarding safeguarding and child protection.
- maintain accurate safeguarding records that are stored securely.
- be available during school hours.
- arrange cover of DSL role for any out of hours/out of term activities.
- represent school in multi-agency meetings.
- be provided with appropriate support and supervision to carry out the role safely and effectively.
- understand relevant data protection legislation and regulations, especially the Data Protection Act 2018 and the General Data Protection Regulation.

**Induction,  
Training

Updates**

**St. Joseph's is committed to providing staff and volunteers with the skills and knowledge needed to safeguard children. We therefore ensure that:**

- ALL staff and volunteers will receive Safeguarding Training on induction using Safeguarding Induction Pack.
- Staff induction will also include Child Protection Policy, Staff Behaviour Policy, Role of the DSL and Deputies, Pupil Behaviour Policy and Safeguarding response to children who go missing from education
- ALL staff and volunteers will receive Safeguarding Training (at least) annually.
- The DSL/s will provide ALL staff, volunteers, and governors with regular safeguarding updates.
- ALL staff, volunteers and governors will read and show an understanding of any updates that are provided.
- DSLs will attend DSL training every year.
- DSLs will update their knowledge, skills and understanding of relevant safeguarding issues on a regular basis.
- The DSL will undertake Prevent awareness training.
- At least one member of staff and one governor will attend Safer Recruitment Training. This will be renewed at least every 5 years.
- ALL staff, volunteers and governors will undertake any additional specialised training on matters such as Child Sexual Exploitation, Prevent, Child on Child abuse, Online Safety, FGM etc as is deemed necessary by the SLT/DSL and that is particularly relevant to the context and needs of the setting
- any staff member will discuss any specific training requirements or gaps in knowledge or understanding with the DSL/s
- Detailed records will be held of staff safeguarding training.

- ALL staff and volunteers report cases of suspected abuse to the DSL. This will be done as soon as possible using the school's agreed format (CPOMS)
- Where a child is at risk of immediate harm, ALL staff understand that they must refer to the Police or Children's Social Care
- ALL staff and visitors know how to refer to Children's Social Care
- DSLs will make a Section 47 referral to Children's Social Care where a child is in need of protection, has been significantly harmed or is at risk of significant harm, in accordance with Lancashire continuum of need and Risk Management Toolkit to determine whether this threshold has been met

- DSLs adhere to policy, procedures and guidance from Lancashire Children's Safeguarding Assurance Partnership (Formally Lancashire Safeguarding Children's Board) with regard to sharing information
- DSLs contribute to Strategy Discussions, Strategy Meetings, Initial and Review Child Protection Conferences, Core Group Meetings and other CP meetings

## Early Help

**St. Joseph's is committed to providing our families with the right help at the right time. Any** child may benefit from early help, but **ALL** school staff should be particularly alert to the potential need for early help for a child who:

- is disabled and has specific additional needs.
- has special educational needs (whether or not they have a statutory education, health and care plan);
- is a young carer.
- is showing signs of being drawn in to anti-social or criminal behaviour, including gang involvement and association with organised crime groups.
- is frequently missing/goes missing from care or from home.
- is misusing drugs or alcohol themselves.
- Is at risk of modern slavery, trafficking, or exploitation.
- is in a family circumstance presenting challenges for the child, such as substance abuse, adult mental health problems or domestic abuse.
- has returned home to their family from care.
- is showing early signs of abuse and/or neglect.
- is at risk of being radicalised or exploited.
- is a privately fostered child.
- any other identified reason not listed above that requires extra support or intervention to improve outcomes for families and children **including mental health support.**

### **We therefore ensure that:**

- ALL staff and volunteers can identify the risk factors that indicate a family or pupil may benefit from Early Help
- ALL staff and volunteers will use the school's agreed format for letting the DSL know about Early Help requirements, recording concerns on CPOM's.
- DSLs will undertake an EHA assessment, when appropriate, to identify what Early Help is required
- DSLs will signpost and refer to appropriate support agencies.
- DSLs will lead on TAF meetings where is it appropriate for them to do so.
- DSLs will utilise Children and Family Wellbeing Service using the referral pathway.
- DSLs will refer to CSC where Early Help has not been successful in reducing risk and meeting unmet needs using Lancashire continuum of need thresholds guidance and CSC Referral Form
- DSLs and other identified staff will identify and work with any organisations that are relevant in meeting the needs of pupils and their families
- DSLs and other identified staff will initiate and maintain positive and supportive relationships with parents and carers of children who may benefit from Early Help
- DSLs or appropriately trained school staff will generally be the lead for Early Help cases if this is in the best interests of the family.

Specific issues include (but are not limited to):</li> </ul> <p><b>Radicalisation:</b> refers to the process by which a person comes to support terrorism and forms of extremism. There is no single way of identifying an individual who is likely to be susceptible to an extremist ideology.</p> <ul style="list-style-type: none"> <li>• St Joseph's recognises that protection from extremism &amp; radicalisation is a vital element of safeguarding</li> <li>• ALL staff and volunteers will have 'due regard to the need to prevent people from being drawn into terrorism', known as the 'Prevent Duty'</li> <li>• ALL staff and volunteers will have a general understanding of how to identify a child who may be at risk of radicalisation</li> <li>• ALL staff and volunteers will use professional judgement in identifying children who might be at risk of radicalisation and act proportionately</li> <li>• The school Online Safety Policy will ensure the safety of children by ensuring they cannot access terrorist and extremist material when using the internet and that suitable filtering software is in place</li> <li>• DSLs understand when it is appropriate to make a referral to the Channel Panel and are aware of how to do so.</li> </ul> <p><b>Child Sexual Exploitation (CSE)</b> involves exploitative situations, contexts and relationships where young people may receive something (e.g. food, accommodation, drugs, alcohol, gifts or simply affection) as a result of engaging in sexual activities. The perpetrator will not only groom the victim (possibly over a long period of time) but will always hold some kind of power which increases as the exploitative relationship develops. Sexual exploitation involves a degree of coercion, intimidation or enticement, including unwanted pressures from peers to have sex, sexual bullying including online bullying (cyberbullying) and grooming. It is important to recognise that some young people who are being sexually exploited do not exhibit any external signs of this abuse and do not recognise that they are a victim of abuse.</p> |

- The school curriculum (whereby sexual relationships/PSHE is delivered) will include relevant information around the risks associated with CSE
- The school Online Safety Policy will ensure the safety of children by ensuring they cannot access inappropriate material when using the internet and that suitable filtering software is in place.

**Child Criminal Exploitation** - is a form of child abuse. It occurs where an individual or group takes advantage of an imbalance of power to coerce, control, manipulate or deceive a child or young person under the age of 18 into any criminal activity:-

- (a) in exchange for something the victim needs or wants, and/or
  - (b) for the financial or other advantage of the perpetrator or facilitator and/or
  - (c) through violence or the threat of violence. Child criminal exploitation does not always involve physical contact; it can also occur through the use of technology.
- CCE:-

- can affect any child or young person (male or female) under the age of 18 years
- can affect any vulnerable adult over the age of 18 years
- can still be exploitation even if the activity appears consensual
- can involve force and/or enticement-based methods of compliance and is often accompanied by violence or threats of violence
- can be perpetrated by individuals or groups, males or females, and young people or adults; and

is typified by some form of power imbalance in favour of those perpetrating the exploitation. Whilst age may be the most obvious, this power imbalance can also be due to a range of other factors including gender, cognitive ability, physical strength, status, and access to economic or other resources.

Criminal exploitation of children can include **County Lines**. This is a geographically widespread form of harm that is a typical feature of county lines criminal activity: drug networks or gangs groom and exploit children and young people to carry drugs and money from urban areas to suburban and rural areas, market and seaside towns or move drugs from A to B. Key to identifying potential involvement in county lines are missing episodes, when the victim may have been trafficked or the purpose of transporting drugs and a referral to the [National Referral Mechanism](#) should be considered in addition to normal safeguarding procedures.

**Honour Based Abuse (HBA)** Honour based abuse is a collection of practices used to control behaviour within families in order to protect perceived cultural and religious beliefs and/or honour. **Violence or abuse** can occur when perpetrators perceive that a relative has shamed the family and/or community by breaking their honour code.

**Forced Marriage** is one whereby one or both parties do not consent to marriage but are forced to do so through violence, threats or any form of coercion. Schools play an important role in safeguarding children from being forced to marry.

**Female Genital Mutilation (FGM)** is encompassed within the term Honour Based Abuse:

- ALL staff and volunteers are aware of the "one chance rule" and will report all cases of suspected Honour Based Abuse or FGM to the DSL immediately
- FGM is illegal in the UK and a form of child abuse with long-lasting harmful consequences.

- Whilst all staff should speak to the designated safeguarding lead (or deputy) with regard to any concerns about female genital mutilation (FGM), there is a specific **legal** duty on **teachers**. If a **teacher**, in the course of their work in the profession, discovers that an act of FGM appears to have been carried out on a girl under the age of 18 or there are concerns this may be about to happen, the teacher **must** report this to the police.

**Modern Slavery** The Modern Slavery Act 2015 places a new statutory duty on public authorities, including schools, to notify the National Crime Agency (NCA) (section 52 of the Act) on observing signs or receiving intelligence relating to modern slavery. The public authority (including schools) bears this obligation where it has 'reasonable grounds to believe that a person may be a victim of slavery or human trafficking':

- Staff must be aware of the above and contact the DSL should they suspect or receive information that either parents or their children may be victims of modern slavery. The DSL should then contact the NCA and follow their normal safeguarding procedures.

**Child on Child Abuse (including sexual violence and harassment)** occurs when a young person is exploited, bullied and / or harmed by their peers who are the same or similar age; everyone directly involved in child on child abuse is under the age of 18.

St Joseph's will refer to specific guidance in Keeping Children Safe in Education Part five: Child on Child Sexual Violence and Sexual Harassment.

This is most likely to include, but may not be limited to: bullying (including cyberbullying); physical abuse such as hitting, kicking, shaking, biting, hair pulling, or otherwise causing physical harm; sexual violence and sexual harassment; sexting (also known as youth produced sexual imagery); and initiation/hazing type violence and rituals. This will also include **Upskirting**. It typically involves taking a photograph under a person's clothing without them knowing, with the intention of viewing their genitals or buttocks for sexual gratification or causing humiliation, distress or alarm.

- ALL staff and volunteers understand that children can abuse other children
- ALL staff and volunteers will inform the DSL of suspected peer abuse and record in line with schools recording policy
- Peer on peer abuse will be taken as seriously as any other form of abuse
- All staff understand that abuse is abuse and should never be tolerated or passed off as "banter", "just having a laugh" or "part of growing up"
- All staff will understand that pupils with SEND are more prone to peer group isolation and school will have extra pastoral support to address this.

- Harmful sexual behaviour will be identified and managed using the [Brook Traffic Light Tool](#) and with support and guidance from LCC Schools Safeguarding Officers
- Sexting – (See specific guidance below in regards to Sexting)
- In cases of suspected or actual child on child abuse a risk assessment will be undertaken and appropriate and proportionate control measures put in place to manage and reduce risk.
- DSLs understand that regarding child-on-child abuse, the victim and the perpetrator are likely to have unmet needs and require support and assessment to determine these.
- The DSL will assess on a case-by-case basis, supported by children's social care and the police if required to ensure the most appropriate response for the children / young people involved
- **The DSL will consider:**
  - the wishes of the victim in terms of how they want to proceed
  - the nature of the alleged incident
  - the ages of the children involved
  - the development stages of the children involved
  - any power imbalance between the children
  - is the incident a one-off or a sustained pattern of abuse
  - are there ongoing risks to the victim, other children, school or college staff
- contextual safeguarding issues.
- **Following a report of sexual violence, the designated safeguarding lead (or deputy) will make an immediate risk and needs assessment, considering:**
  - the victim
  - the alleged perpetrator
  - all other children (and if appropriate adult students and staff).
  - Risk assessments will be recorded and kept under review as a minimum termly.

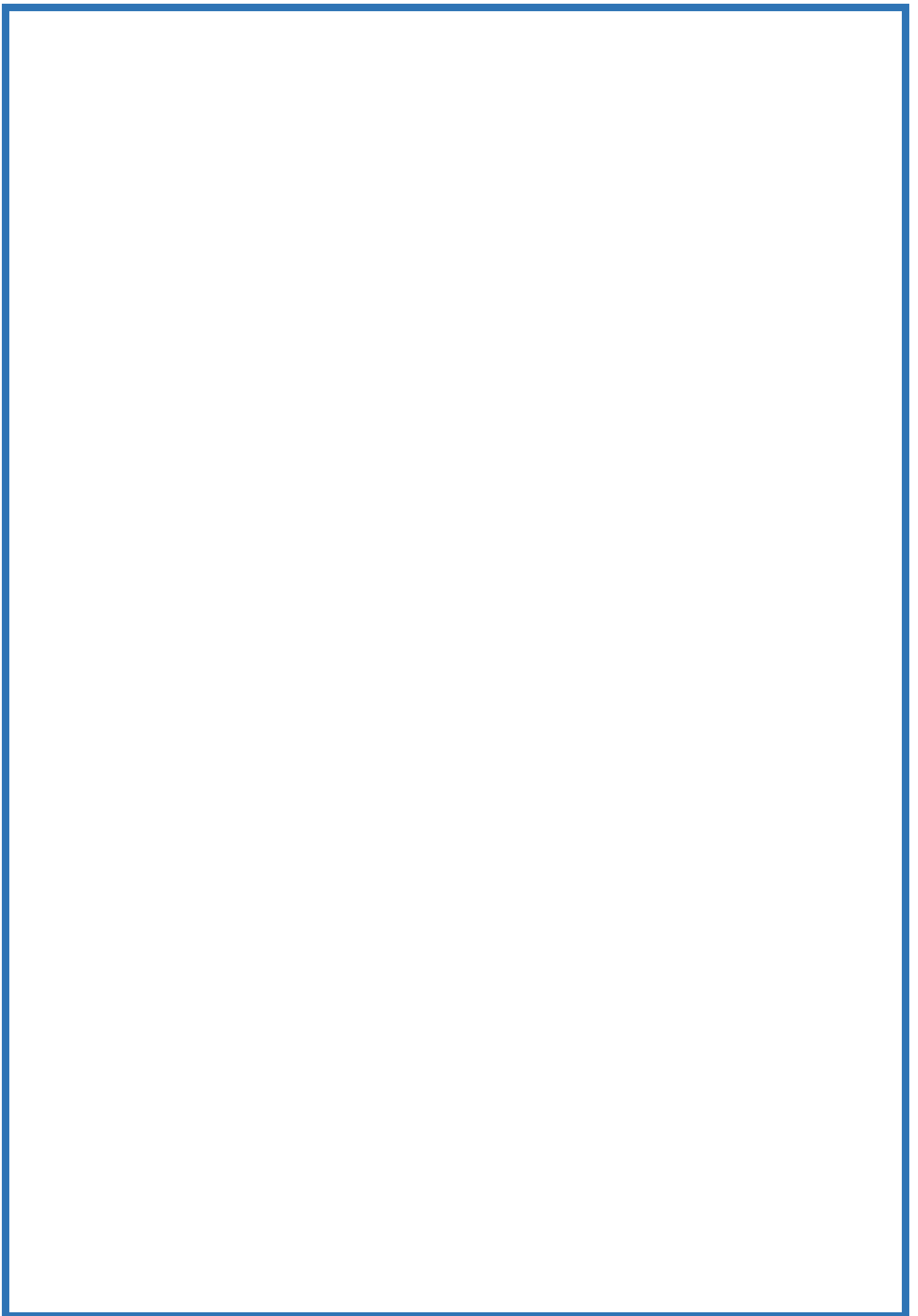

(Further detailed guidance on Child on Child Sexual Violence and Sexual Harassment is found in Keeping Children Safe in Education 2025).

**Domestic abuse** is any incident or pattern of incidents of controlling, coercive, threatening behaviour, violence or abuse between those aged 16 and over who are, or have been, intimate partners or family members regardless of gender or sexuality. The abuse can encompass, but is not limited to:

- Psychological
- Physical
- Sexual



- Financial
- Emotional

Exposure to domestic abuse and / or violence can have a serious, long lasting emotional and psychological impact on children. In some cases, a child may blame themselves for the abuse or may have had to leave the family home as a result.

- ALL staff and volunteers understand what domestic abuse is and the potential impact upon children and how this might be displayed. **The DSLs will:** -
- Ensure that the school has suitably trained Key Adult/s in order to fulfil its obligations under Operation Encompass
- Ensure that the school's commitment to Operation Encompass is known throughout the school community via the means of staff training, parental letters, posters and the school website
- School will provide an overview of Operation Encompass with the names of the Op Encompass leads and a link to the Op Encompass website (<https://www.operationencompass.org/>) Operation Encompass lead(s) at St. Joseph's Catholic Primary School are Miss R Griffiths, Mrs Nicole Dodd and Mrs L Beaumont.

**Children Missing from Education** can be a potential sign of abuse or neglect **including** sexual exploitation, child criminal exploitation, undergoing female genital mutilation, forced marriage, or travelling to conflict zones.

- ALL staff and volunteers follow school procedures when a child misses education particularly on repeat occasions to help identify the risk of abuse and neglect
- The school Securing Excellent Attendance Policy is up to date, reviewed annually and includes reference to CME and procedures followed in the case of children missing or who have attendance concerns
- There is an admissions policy and an attendance register
- The Local Authority is informed of any pupil who fails to attend school regularly, or has been absent without the schools permission for a continuous period of 10 school days or more
- **Where reasonably possible** school will hold more than one emergency contact number for their pupils and students.
- ALL staff will be aware that children going missing from education can be a warning sign of safeguarding considerations.

**Sexting** is defined as the production and/or sharing of sexual photos and videos of and by young people who are under the age of 18. ([UKCCIS, 2016](#)), It includes nude or nearly nude images and/or sexual acts. It is also referred to as 'youth produced sexual imagery'. 'Sexting' does not include the sharing of sexual photos

and videos of under-18 year olds with or by adults. This is a form of child sexual abuse and must be referred to the police.

- School staff are aware of how to manage sexting incidents and must pass on any incidents or concerns to the DSL

- School staff are aware that they should never view, download or share the imagery, or ask a child to share or download – this is illegal
- If staff have already viewed the imagery by accident (e.g. if a young person has showed it to them before they could ask them not to), report this to the DSL
- Staff will not delete the imagery or ask the young person to delete it.
- Staff will not ask the young person(s) who are involved in the incident to disclose information regarding the imagery. This is the responsibility of the DSL
- Staff will keep details of the incident confidential, reporting this to the DSL
- Staff are mindful not to do anything to blame or shame any young people involved
- The incident will be followed up by the DSL or Deputies and follow appropriate guidelines as set in [\(UKCCIS, 2016\)](#).
- If the DSL/ SLT must view the images, this should be discussed and done so in a private space and the reasoning behind this must be logged on the incident report.

#### **Other vulnerable categories**

- ALL staff will have read Annex A of Keeping Children Safe in Education and be aware of specific forms of abuse and safeguarding issues and vulnerable groups of children including;
- Children in the Court system;
- Children with family members in prison
- Child Criminal Exploitation
- Homelessness
- For all specific safeguarding issues, DSLs will seek advice from LCC Schools Safeguarding Officers or MASH Education Officers and follow national and local guidance.

- Relevant, proportionate and lawful checks are undertaken on all adults who regularly work at, or visit the school
- A Single Central Record is kept of checks that are undertaken on all adults who regularly work at or visit the school.
- The SCR is stored securely, you can store electronically or paper – St Joseph's SCR is stored electronically, is password protected and only accessed by designated staff and governors.
- DSLs/HT/Safeguarding Governor/Chair of Governors should evidence regular (at least termly) oversight/scrutiny of the SCR
- Evidence of staff members identity, required qualifications and the right to work in the UK will be kept in individual personnel files, uploaded electronically to Arbor system.
- Covering (umbrella) letters will be obtained from agencies and other employers that provide staff to work in school to confirm that appropriate checks have been undertaken. Agencies will be requested to complete the checklist found at Appendix Q of the R&S Guidance.

If a waiver is necessary, a risk assessment will be carried out and proportionate measures put in place until a waiver has been issued or matters resolved.
